## **SYLLABUS**

Course description (a brief description of the course, general instructions, where and in what form the lessons are organized, necessary equipment, instructions for attendance and preparation for classes, student obligations, etc.):

The course **Dental ethics and deontology** is a compulsory course in the first year of the Integrated Undergraduate and Graduate University Study of Dental Medicine and consists of 15 hours of lectures and 15 hours of seminars, totaling 30 hours (3 ECTS). The course is delivered via e-course on the Merlin platform and in the premises of the Faculty of Dental Medicine.

The aim of the course is to get acquainted with the ethical determinants of dental professionals: the relationship with the patient, colleagues, society and biomedical research.

The content of the course is as follows:

Morality, ethics, bioethics: conceptual distinctions; Professional duties and Code of dental ethics and deontology; Ethics of the relationship between dentists and patients; Patient autonomy; Privacy and confidentiality; Informed consent to treatment and refusal of treatment; Dental profession and community; Ethics and professionalism of dentists in digital media, using photographs and advertising; Ethics in scientific research; Ethics and business management

### Teaching:

Teaching is held in the form of lectures and seminars. In the seminar, the lecturer assesses the students' readiness to present the topic and moderates the discussion. There is a final examination at the end. By completing all teaching activities 3 ECTS points is acquired.

## The list of lectures (with topics and descriptions):

## P1. Morality, ethics, bioethics: conceptual distinctions

Learning outcomes:

To define the concepts of morality, ethics and bioethics and describe the relationship and connections.

## P2. Professional duties and code of dental ethics and deontology

Learning outcomes:

To list professional duties in dental medicine, dental ethics and deontology and describe the relationship.

#### P3. Central values of the dental profession

Learning outcomes:

To distinguish professional duties and values.

## P4. Ethics of the relationship between dentist and patient

Learning outcomes:

To describe the types of relationships; describe the terms autonomy, paternalism

## P5. Patient autonomy

Learning outcomes:

To analyze the norms of treatment of persons who are not competent to give consent in the dental practice.

#### P6. Informed consent to treatment and refusal of treatment

Learning outcomes:

To define the contracting parties and describe the content of the informed consent or refusal of treatment.

## P7. Privacy and confidentiality in dental practice

Learning outcomes:

To describe the concepts of privacy and confidentiality.

#### P8. Poor professional outcome and work

Learning outcomes:

To describe procedures for dealing with poor professional work.

## P9. Conflict of professional duties and/or values

Learning outcomes:

Distinguish between professional duties and values.

## P10. Dental profession and community

Learning outcomes:

To describe the concepts of social justice and access to oral health care.

## P11. Ethics and professionalism of dentists in digital media

Learning outcomes:

To describe ethical behavior in digital media.

## P12. Advertising in dentistry

Learning outcomes:





To describe the standardization of advertising. Discuss the ethics of surreptitious advertising.

#### P13. Ethics in using dental photographs

Learning outcomes:

To develop critical thinking about dilemmas related to using dental photographs.

#### P14. Ethics and business management

Learning outcomes:

To describe business principles according to ethical frameworks.

#### P15. Ethics in research

Learning outcomes:

To know ethical norms in research and publishing papers. Describe the role of the ethics committee and the content of informed consent within the research.

## The list of seminars with descriptions:

#### S1-5. Ethical aspects of dental profession

Students independently prepare and publicly present a seminar on a given topic dealing with ethical aspects of their future profession. Also students are discussing situations from dental profession with professor.

## Students' obligations:

Students are required to attend regularly and participate actively in all forms of education. Seminar and final exam are required.

## Assessment (exams, description of written / oral / practical exam, the scoring criteria):

ECTS credit grading system:

Student assessment is carried out according to the current Regulations on Studies of the University of Rijeka.

Student work will be evaluated and graded during classes and at the final exam. Out of a total of 100 grade points, a student can achieve 50 points during classes and another 50 points on the exam.

Student assessment is performed using ECTS (A-F) and number system (5-1). Grading in the ECTS system is performed by absolute distribution.

Students who gain from 0 to 24.9% of grades that could be obtained during classes through forms of continuous monitoring and evaluation of students are graded F (unsuccessful), can not gain ECTS credits and must re-enroll the course.

The student gains grades by actively participating in classes and performing the set tasks.

## <u>During the classes, the seminar paper is evaluated (maximum up to 50 points):</u>

The grade of the presented seminar paper carries 50 grade points (passing grades in the range of 25-50), and is converted into grade points as follows:

## Final exam (total 50 points)

#### Who can take the final exam:

Students who achieved 25% and more grade points during classes through forms of continuous monitoring and evaluation of students.

## Who cannot take the final exam:

Students who achieved from 0 to 24,9% of grades during classes are graded F (unsuccessful), can not gain ECTS credits and must re-enroll the course.

The final exam is written (it can be in a form of multiple answers questions or answers in free form), carries 50 grade points (passing grades ranging from 25-50). The the case of multiple answers questions resolution ratio is multiplied by a weight of 0.5. The limiter is 50%. When having test in free form grade is convertes in scalar poins in this manner:

To pass the final exam and for the final grade (including the addition of previously achieved grade points during classes), the student must have a positive grade in the final exam and achieve a minimum of 25 grade points (50%).
